DESCRIPTION

#1 Deck Wood Cleaner is a powdered concentrate that is mixed with water. It safely cleans and restores the natural beauty of exterior wood. This product also cleans weathered composite lumber, removing mold, mildew and algae along with the silver-gray color that can develop over time. Restores all wood surfaces to their original appearance. #1 Deck Wood Cleaner will not harm wood fibers, pets, grass, or most plants. This product is step 1 of a 3 step system.

USES

#1 Deck Wood Cleaner removes dirt, grime, mold and mildew stains, and weathered graying from horizontal and vertical wood surfaces. It is recommended for surface preparation prior to application or reapplication of wood stains. For best results use #1 Deck Wood Stains.

ADVANTAGES

- Removes stains caused by mold and mildew
- Removes wood graying caused by UV rays
- Removes existing, weathered stains
- Removes dirt and debris

Limitations: #1 Deck Wood Cleaner will darken redwood. Use #1 Deck Wood Brightener to restore redwood to its original

color or as a neutralizer to further brighten other wood species that have been cleaned with #1 Deck Wood Cleaner.

DIRECTIONS FOR USE

STEP 1 MIX: Mix 6 ounces (3/4 cup) of cleaner with each gallon of water and stir thoroughly until powder is mostly dissolved. Powder dissolves faster in warm water. Solution should be used within six hours of mixing.

STEP 2 APPLY: Dampen surface with water before application. Apply #1 Deck Wood Cleaner solution with pump sprayer, brush, or the #1 Deck Push Brush (or any car wash type brush). If applying with a pump-up sprayer, we recommend pouring the solution through a paint strainer first, to filter out any undissolved granules that can clog the sprayer tip.

Work on small areas, (20-30 sq. ft.) at a time. For vertical surfaces, begin at the bottom and work to the top.

STEP 3 BRUSH: Let solution stand approximately 15-20 minutes, keeping area wet with additional #1 Deck Wood Cleaner solution. Thoroughly scrub with a stiff, short bristle broom or brush.

#1 Deck Wood Cleaner will open wood pores and some raising of wood fibers may occur.

STEP 4 RINSE: Rinse thoroughly with water from hose or pressure washer using lowest pressure that cleans without damaging the wood. Repeat steps 2-4 on next small area. Rinse cleaned area of vertical surfaces to avoid streaking as work progresses.

Heavily weathered or soiled surfaces may require a second application. While still wet after cleaning the entire project, proceed to step 2 and neutralize the wood with #1 Deck Wood Brightener. This is an essential step before staining.

COVERAGE: One container of #1 Deck Wood Cleaner will make 5 gallons of cleaning solution and cover approximately 500-1,000 sq. ft. depending on surface porosity and method of application.

CLEAN UP: Clean tools and equipment immediately after each use with soap and water.

CAUTIONS

Keep out of reach of children. Do not take internally. Avoid contact with eyes and mucous membranes and prolonged contact with skin. Avoid breathing mist. Close container tightly after each use. Do not re-use containers. Contains sodium carbonate peroxyhydrate. Do not mix with chlorine bleach or

other chemicals. Store in original container only. Sweep up spills and flush down drain. Contact with combustible organic materials may cause fire. Accumulation of product on ladders, scaffolding, decks, etc., may result in a slippery surface.

FIRST AID

IF INHALED: Move to fresh air. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Never give an unconscious person anything to drink. Immediately call a POISON CENTER or doctor/physician. Oxygen and/or artificial respiration may be necessary. FOR SKIN CONTACT: Remove/Take off immediately all contaminated clothing. Wash off immediately with soap and plenty of water. Get medical attention if irritation persists. FOR EYE CONTACT: Immediately flush eyes thoroughly with water for at least 15 minutes, including under the eyelids. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical attention immediately. In case of difficulty in opening lids, administer an analgesic eye wash (oxybuprocaine).
